Pre-Con Workshop for Treatment Providers

Treating Gambling Harms: Valuable strategies for engaging and retaining our clients

Speaker: **James Whelan, PhD**, University of Memphis

The evidence supports that gambling-specific treatment can reduce symptoms, gambling behavior and potentially enhance well-being. At the same time, only 10 to 15 percent of individuals experiencing gambling harm seek treatment and 39 percent of treatment seekers discontinue treatment before a therapeutic dose. This session will review the evidence and strategies for addressing treatment hesitancy and dropout.

Medical Interventions for Gambling Disorder: The Past, Present, and Future

Speaker: **Jon E. Grant, JD, MD, MPH**, The University of Chicago

The field of research on gambling has evolved considerably since gambling disorder was first recognized by the American Psychiatric Association's *Diagnostic and Statistical Manual of Mental Disorders* in 1980. In the beginning people with gambling problems could access Gamblers Anonymous groups, founded in 1957. But slowly other strategies for recovery were developed, especially behavioral and pharmaceutical approaches that were successful with other addictive disorders. Leading gambling researcher Jon Grant will trace this history and look ahead to see what other promising treatments might be on the horizon for treating gambling disorder.

Digital CBT: Expanding Treatment Options for Gambling Disorder

With support from the Mohegan Tribe in Connecticut, Dr. Potenza is developing digital therapeutic tools, such as a Cognitive-Behavioral Therapy (CBT)-based mobile app, to ensure greater access to care for traditionally underserved populations. This initiative will develop state-of-the-art tools specifically designed to address gambling disorder. Dr. Potenza will report on the clinical trials testing for effectiveness and safety.

Disparities for Gambling Treatment Service Use in the Latinx Community

Panel: **Michael Campos, PhD**, University of California, Los Angeles
Hugo Ramirez, Vision y Compromiso

The prevalence of gambling disorder among Latinx individuals in the U.S. is similar to that seen in the non-Latinx Caucasian community. However, there are disparities in the use of State-funded treatment for such problems in California. Dr. Campos and Mr. Ramirez will report on pilot research using community health workers to increase Latinx utilization of services in Los Angeles and San Diego Counties.

Mindfulness-Based Relapse Prevention (MBRP) was developed to treat substance use disorders, but its core principles can be readily applied to the treatment of behavioral addictions. Dr. Shirk will present a series of case studies describing the application of a manualized mindfulness treatment used with U.S. veterans seeking outpatient treatment for GD at a Department of Veterans Affairs hospital.

People rarely ask, what do clinicians think about their practice and the pace of the changing gambling landscape? This focus group, representing treatment providers from three very different regions, will express their concerns about improving treatment for people with gambling problems.

Who's Responsible for Responsible Gambling? What Players Say (1 CE Hour)

Speaker: **Eric Louderback, PhD**, Cambridge Health Alliance and Harvard Medical School

Academics, gambling regulators and the gambling industry increasingly espouse a shared responsibility view of preventing gambling harm. This view considers individual gamblers and external stakeholders, such as casino employees, to be jointly responsible for minimizing gambling harm. But do individual gamblers share this view? Dr. Louderback will present the findings from a three-year study of participants sampled from a casino's customer loyalty program database.

- A recent publication in a scientific, peer-reviewed journal that represents seminal work in the field

GUIDELINES FOR SUBMITTING A NOMINATION

The nomination package must include the following:

- Letter of recommendation: A detailed letter describing the worthiness of the nominee or nominated work, specifying the contribution to the field of gambling studies and significance.
- Curriculum vitae (CV):
 - For individual nominees, include an up-to-date CV
 - For research investigators, include a comprehensive bibliography of the nominee's publications
- Publications: For research investigators, submit no more than five scientific publications representative of the nominee's work. When nominating a publication, include a copy of the published version of the article. The publication must have been published in the same year or the year prior to the nomination.

Submit nomination materials to Travis Sztainert (tsztainert@icrg.org) by **Aug. 15, 2024**. The selection committee, composed of distinguished scientists in the addictions field, will select the recipient of the 2024 ICRG Scientific Achievement Award. The award will be presented at the awards luncheon during the ICRG conference on Monday, Oct. 7, 2024.

The ICRG showcases new research on gambling disorder and responsible gambling during a poster session and reception held at the ICRG Conference. SUBJECT MATTER

Posters can focus on any aspects of gambling disorder and responsible gambling and must report on empirical research. Abstracts will be reviewed for scientific merit.

SUBMISSION GUIDELINES

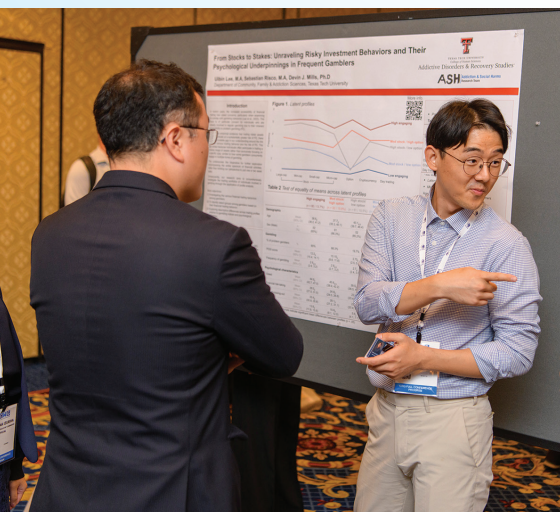
Abstracts should be submitted electronically in MS Word® or another word processing software using a font size no smaller than 12 pt. PDFs will not be accepted. Please include the following information:

- Title of Presentation
- Name(s) and affiliation(s) of the author(s)
- Email address of the first author
- Poster abstract (no more than 500 words). Please follow APA format for text and references. The abstract should address the following:
 - Sample and methods
 - Preliminary findings
 - Implications for the field
- Digital signature of first author certifying that any work with human or animal subjects in the abstract complies with the guiding policies and principles for experimental procedures of the World Medical Association of Helsinki.

By submitting a poster, at least one author must agree to attend the conference and to participate in the poster session. No individual can be first author on more than one submission.

Abstracts will be accepted on a rolling basis until Aug. 15, 2024.
